


Background

- Post-mortem care is often viewed as a challenging subject for the involved nursing staff.
- Research has also identified that institutional deaths will be an increasing trend over the next few decades.
- Educating staff on post-mortem practices is of increasing importance in the institutional setting, with the goal of increasing staff comfort with end-of-life practices.

Practice Change

Integrate an easily accessible resource to educate staff on postmortem care




Methods

- Administered anonymous paper pre-surveys to RNs
- Provided Postmortem education by having RNs read through Postmortem Care resource binder
- Administered anonymous paper post-surveys to RNs 3 days after education provided

Provide a post-mortem care educational binder to other units at NLEMMC

Follow and track nursing's confidence and ability to perform post-mortem care after they've reviewed the binder


Continue to provide education to staff working in the clinical setting


Barriers of Study:


Lack of time to complete pre- and postsurveys

Lack of need for post-mortem care in unit during study

Conclusion

- Overall, post-mortem care education proved beneficial for P6 RN staff
- 25 of the 26 surveys expressed increase in RN staff confidence and knowledge of postmortem care
- Barriers include: one binder for floor, lack of time for survey completion, and lack of need for post-mortem care during time of study
- Staff reported that post-mortem care binder was helpful and easy to navigate compared to previous policy formats
- From personal experience, the binder has been extremely helpful in navigating postmortem care and the RNs duties
